3-ON-3 Basketball Tournament Info

Tournament will be held at **Luis R. Lopez Playground** (629 Targee St) on the corner of Palma Drive and Targee Street across from Home Depot in the Clifton area of Staten Island. If you are unfamiliar with the Park, call NYC Parks & Recreation prior to date of event for directions, (718)390-8023. Sign-in starts at **9:00** and ends at **9:30 a.m.** Play will begin at **10:00 a.m.**

Teams will consist of 3 or 4 players and compete within three divisions. The adult, or open division, is for players 16 and up. The teen division is for players aged 13 to 15. And the youth division is for players 12 and under. Younger players may move up with parental consent but not down. Registration must be done in advance by:

**** Please note, all players must sign waiver and show photo identification in order to compete.** Players under the age of 18 must have parental consent. Please print and bring signed waiver to the tournament. **You will not be allowed to play without parent or guardian signature!**

Team captains are responsible for team actions and behavior at all times. OTA stresses the importance of good sportsmanship on and off the court. Players exhibiting inappropriate or aggressive behavior will be immediately disqualified and asked to leave the premises.

**** To qualify for discounted price of \$40 (\$20 Youth), payment must be received by July 20, 2012.** Entries received after July 20 will only be included if space permits, and the team registration fee will increase to \$50 (\$25 Youth).

Rules and Regulations:

Play will consist of two teams of three players each on the court at a time. The game will consist of two 10 minute halves with a 2 minute break between halves. Points will be awarded as follows: 3 points for shots made from beyond the arc, 2 points for shots made inside the arc or on the line.

No free throws will be awarded. When a foul is committed, as determined by the referee, the opposing team will be awarded possession of the ball. Players are allowed 3 personal fouls per game. Any player committing a fourth foul will be disqualified and must exit the game immediately. Teams of three will forfeit any game in which a player fouls out. Teams of four may continue play with only three players after one player fouls out.

Home and Away will be determined by order drawn. The home team will start each game with the ball, while the away team will get possession at the start of the second half. If a game ends in a tie, another 3 minute period will be played until the game ends with a winning team. Possession will continue to alternate at the start of each additional period.

All teams are guaranteed a minimum of two games with initial matchups determined by draw. Tournament structure will depend on the number of teams registered and may be modified at the sole discretion of OTA organizers. Teams must be present and ready to play when called or risk forfeit. Play will continue until one winner is decided.

**** The word of any OTA representative (timekeeper, ref, etc.) is final.**

The preceding are rules specific to the tournament and may be modified at any time at OTA's discretion. The basic rules of basketball also apply. Please remember to have fun and practice good sportsmanship!
